<u>Section 3210</u>	(Service Claim Requirements) General Requirements	Added requirement that a service claim for in-home day habilitation and in-home respite match the EVV visit transaction
<u>Section 3510</u>	15-Minute Unit of Service	Added in-home respite as 15-minute unit of service
<u>Section 3520</u>	Daily Unit of Service	Added in-home day habilitation as daily unit of service
<u>Section 4220</u>	(Professional Therapies) Billable Activity	Deleted the requirement that a service provider of professional therapies cannot review written service log or written summary log as a billable activity
<u>Section 4230</u>	(Professional Therapies) Activity Not Billable	Added the service provider of professional therapies can review a written service log or written summary log as described in Section 4220(4)
<u>Section 4320</u>	(Day Habilitation) Requirement of Setting	Revised Section 4320 to require that Day habilitation must be provided to an individual in a setting that is not the residence of the individual.
<u>Section 4350</u>	(Day Habilitation) Restrictions Regarding Submission of Claims for Day Habilitation	Added a restriction for Day Habilitation provided that contravenes a physicians order, a behavioral support provider or for an individual who is 55 years of age or older and chooses to receive in-home Day Habilitation

Section 4360	(Day Habilitation) Qualified Service Provider	Deleted requirement that a qualified service provider must not be the host home/companion care service provider unless the day habilitation services are provided at a location that has a different address from the individual's residence.

Section 4381	In-Home Day Habilitation	Added New Section In-Home Day Habilitation *Section 4381 In-Home Day Habilitation is a new section [added] and [deleted] shows the changes made from Section 4300 Day Habilitation
Section 4381.3	(In-Home Day Habilitation) Requirement for Justification by a Licensed Professional or to be 55 years of age or Older	Added new section
Section 4381.4	(In-Home Day Habilitation) EVV Requirements for In-Home Day Habilitation	Added that for individuals who have a residential location of "own home/family home" must comply with 1 TAC Chapter 354, Subchapter O, Electronic Visit Verification
Section 4620	(Respite) Requirement of Setting	Revised Section 4620 that respite can only be provided in a location that is not the individual's residence and the locations where respite can be provided

<u>Section 4630</u>	(Respite) Billable Activity	Added billable activities, participating in a service planning team meeting, participating in the development of an implementation plan; and participating in the development of an IPC
<u>Section 4651</u>	(Respite) Restrictions Regarding Submissions of Claims for Respite	Deleted Restriction that limits respite to 10 hrs per calendar day when provided in a location other than the individuals residence
<u>Section 4680</u>	(Respite) Payment Limit	Added that the payment limit for respite, in-home respite or a combination of both is 1200 units (300 hrs) and respite and in-home respite is the same program service on the IPC.
<u>Section 4691</u>	In-Home Respite	Added New Section In-Home Respite *Section 4691 In-Home Respite is a new section [added] and [deleted] shows the changes made from Section 4600 Respite
<u>Section 4691.2</u>	(In-Home Respite) Requirement of Setting	Added that in-home respite can only be provided in a location that is the individuals residence.
<u>Section 4691.3</u>	(In-Home Respite) Billable Activity	Added billable activities, participating in a service planning team meeting, participating in the development of an implementation plan; and participating in the development of an IPC
<u>Section 4691.9</u>	(In-Home Respite) Payment Limit	Added that the payment limit for respite, in-home respite or a combination of both is 1200 units (300 hrs) and respite and in-home respite is the same program service on the IPC.
