

  - Receiving providers can view the individual's historical forms for their specific waiver program.

## Training & Information Sharing: Appendix A – IPC Revision



- When changing residential types via IPC Revision, please do the following:
  - Change location in field 2f.
  - Change location type in field 10.
  - Prorate and end services on old residential type.
  - Add the new service at a prorated amount.

Note: Residential services cannot exceed 365 (366 Leap Year). Prorate.

## Training & Information Sharing: Using "Submit Form"



- Use Submit Form instead of Use as Template under these conditions:
  - There have been rate changes or enhancements.
  - A provider or financial management services agency (FMSA) has been removed, added, or changed.
  - The form is not autofilling with the most current information, and all other forms (e.g., transfers or individual updates) are correctly processed and in Processed/Complete status.
- Before using the *Use as Template* option, ensure that all related forms are correctly processed and marked as Processed/Complete.

This information is posted on the TMHP 1915c website and sent via a GovDelivery Alert on October 13, 2023.
