

Medicaid Provider Notification:

EVV REQUIREMENTS FOR DELIVERY OF COMMUNITY FIRST CHOICE PROGRAM SERVICES

This notification provides information to Home and Community-based Services (HCS), Texas Home Living (TxHmL), Deaf Blind with Multiple Disabilities (DBMD), and Community Living Assistance and Support Services (CLASS) program providers about their responsibilities regarding the implementation of electronic visit verification (EVV) under Community First Choice (CFC). The Health and Human Services Commission (HHSC) will implement CFC on June 1, 2015, and any HCS, TxHmL, DBMD, or CLASS provider contracting with a managed care organization (MCO) to provide CFC services in STAR+PLUS and STAR Health will be required to use EVV.

EVV Implementation Date

Effective **June 1, 2015**, providers contracting with an MCO to provide basic attendant and habilitation services (CFC services) offered under STAR+PLUS and STAR Health will be required to use an HHSC-approved EVV system to record on-site visitation with the member.

The HHSC EVV initiative affects service providers who provide basic attendant and habilitation services in the home and in the community. All agencies providing covered services to a Texas Medicaid managed care member must use an HHSC-approved EVV system to record visit arrival and departure times. The provider agency will use the time recorded in the EVV system to determine billable units/hours before requesting payment. Participation in EVV is optional for consumer directed services (CDS) employers enrolled in programs that require the use of EVV.

NOTE:

- CLASS providers will continue to be subject to EVV for the delivery of personal attendant services/habilitation services under the Department of Aging and Disability Services (DADS) CLASS waiver program, in addition to habilitation services delivered under a CFC contract with an MCO.
- EVV will not apply to HCS and TxHmL program providers delivering CFC services to individuals enrolled in DADS HCS and TxHmL waiver programs.

Required EVV Vendor Selection

Provider agencies under contract with an MCO to provide CFC services must select an HHSC-approved EVV vendor during the contracting process with the MCO. The MCO will provide an EVV vendor selection form that includes vendor contact information with each CFC contract application. Each Financial Management Services Agency (FMSA) is required to select one EVV vendor no later than August 1, 2015. The EVV vendor selected by the FMSA will provide their EVV system to all CDS employers choosing to participate in EVV.

The HHSC-approved EVV vendors are Care Monitoring 2000, DataLogic (Vesta), and MEDsys. At this time, two of the three vendors are accepting new providers. Care Monitoring 2000 has

temporarily closed provider enrollment to its EVV solution. The following vendors are committed to accepting any providers: DataLogic (Vesta), and MEDsys.

Care Monitoring 2000 remains an HHSC-approved EVV system and an active participating vendor in the HHSC EVV initiative.

EVV Vendor Selection Changes

Providers that voluntarily selected an EVV vendor cannot request an EVV vendor transfer until after the EVV implementation grace period ends on August 31, 2015. Beginning September 1, 2015, providers may submit advance notice of a request to transfer to another EVV vendor 120 calendar days prior to the effective change date. HHSC will publish more information regarding the transfer process prior to the eligible submission date.
